### **BOARD OF EXAMINERS MEETING**

May 18, 2022

#### 1. A. Call to Order and Confirmation of Attendance

Governor Greg Gianforte, as President of the Board of Examiners (Board), called the meeting to order on May 18, 2022, at approximately 9:00 a.m. in the Governor's Reception Room of the State Capitol with Secretary of State Christi Jacobsen and Attorney General Austin Knudsen present.
